Section 2 of Local Law No. 5 of year 2000 of the Town of Caroline, entitled "A Local Law of the Town of Caroline, State of New York, providing for a Partial Tax Exemption for Real Property Owned by Persons With Disabilities Whose Incomes are Limited by Reason of Such Disability," is hereby amended to read as follows:

"2. Real property located in the Town of Caroline, owned by one or more persons each of whom is disabled and whose income is limited by reason of such disability or real property owned by husband and wife, or siblings one of whom is disabled and whose income is limited by reason of such disability shall be partially exempt from taxation by said Town for the applicable taxes specified in Section 459-c based upon the income of the owner or combined income of the owners. Such partial exemption shall be to the extent set forth in the schedule following.

<u>ANNUAL INCOME</u>	<u>PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION</u>
Not more than \$21,500	50 percent
More than \$21,500 but less than \$22,500	45 percent
