Frank Proto noted that tax bills had a change of 10.6% over last year.

Monthly Reports

County Representative

Legislature will be dealing with nursing shortage in county. Rep. Proto will continue this year on health committee. He sits on the new personnel committee; health care costs are affecting the county seriously. Continueing on planning committee and the farm and ag protection board. Just appointed to soil and water conservation district. Approved 20K for Town of Caroline Barrile progect. Next legislature meeting will discuss: keeping single year assessmant review or going on a different cycle; tax abatements; consumer issues, such as NYSEG. They've begun to change the cycle of when your bill is due. They say new computer system will bill every 22 days, which means 16 ½ bills every year. Proto has written to Senator Bruno. Another issue is that the cost of gas has come down, but it has not come down on our bills. Smoking: noted that the county has just granted second waver to a business.

Department, Committee, & Liaison Reports

Steve Nicholson

Reported on Environmental Management Council. One of the highlights of the year was selling bags and baskets. Baskets say "Paper or Plastic. No thanks." Created a wind tower ordinance to be distributed to towns throughout the county and to the state. Hired an intern that researched all available ordinances to put together the paper. This is for commercial use, not residential. Big project was backyard burning "If your're smelling it, you're breathing it" campaign. Result was that in Oct, the Board of Health amended the health code to prohibit household burning county-wide. Law probably will go into effect in May or June. They've formed committees: education and energy committees, environmental review committee. Passed a resolution encouraging Cornell to continue monitoring Lake Source Cooling. Web site committee; web site on county planning site.

Discussion: Mahlon is a one-man operation, and his prices are going up every year. Seely concerned he might not have time or the means to do the work and also that Thayler and Thayler have paralegal staff to do work cheaper. They represent the Town of Lansing. Mahlon has not been getting things done in a timely manner in the past year.

Guy K. Krogh attended the meeting and fielded questions from the board. Noted that he would be available for questions by phone during town board meetings he was not required to attend. Discussed his experience working with comprehensive plans. Only area that's coming into play from a legal perspective is that counties are starting to write comprehensive plans, and towns' plans need to be in compliance. Zoning now needs to be in compliance with a county plan. His best recommendation is for public involvement in developing the plan to avoid legal issues down the road. Discussed difference between when charging at a legal vs. a paralegal rate. Noted that he would serve on a committee voluntarily for no charge but as added value in case we're looking for grant money to show contribution in kind.
