Privilege of the Floor

Steve Nicholson, municipal rep to the environmental management council, came from TRIA meeting. They're interested in using Caroline's wind project as a demo project and will provide all the materials necessary to carry that out. Energy Independent Caroline is working on options.

Dmitri Levchenkov from Cornell Cycling Club is setting up a race to be staged at Caroline Center, starting and finishing at the Old 76 Club. Will notify all residents along the road about the race. The race judges need a form that says the town does not object to the race. The town will be named as the coinsured on the insurance policy. A map is available on cornellcycling.org. Rain or shine.

Town business

Candidates for code enforcement officer

Tim and Dominic interviewed 5 candidates and asked 2 to present to the board tonight.

Ed Heatherington. Gave background. Previously code enforcement officer in Enfield. Is signed up for the civil service on June 3. Still has cases pending in Enfield, but will have no problem fulfilling 30 hours per week. Could start as early as tomorrow.

John Daniels: Gave background. Has taken code enforcement certification. Has been involved in building code review as part of his own construction and remodeling business. Needs to finish a couple construction projects. Would be available for 30 hours per week within a couple weeks.

Midnight Sun Structural Analysis

All the finished portions of the building need to be removed, because they contain the majority of the mold. This is selective demolition. Nearly 3000 ft of trusses are salvageable. The large section behind the front-most portion is mostly salvageable. The portion behind that has water wicking up through the masonry wall and the slab. Back area with the coolers needs to come down. The area to the right of the main building, which was apt., has majority of the mold. Small portion behind that needs to come down immediately. How can we incorporate 1400 sq ft of useable space into a larger building? At least \$40 per sq foot, the salvaged area recovers the cost of purchasing the parcel.

Taft Road Tower

Letter from Lee Shurtleff, Dept. of Emergency Response. Contained answers to our list of questions. Will ask them to resolve several issues: need for a drainage plan, engineer certification that tower will only fall at the break point, assessment issue, snow and ice removal.

Liaison report

Steve Nicholson. In the fall will be working on woodlands. County will look for ways to protect those woodlands. The state will no longer manage forests for only timber, but for other purposes like human recreation and ecological habitats. Deer management: 400,000 need to die each year in NYS in order to stay at present population. Only management technique that works is issuing doe permits. Enforcement of open burning is strictly on a complaint basis; health dept. will come out and give educational materials (on first offense). The dept of health does not have to be there during burn; only need evidence that there was a burn.

Adopt All-Hazards Mitigation Plan

By Councilwoman Farnum; Seconded by Supervisor Barber

WHEREAS, Tompkins County and the municipalities therein have identified a history of damages resulting from flooding, severe storms, winter storms, and other weather-related phenomena, and have recognized the potential for future damages resulting from natural, human-caused, and technological disasters, and

WHEREAS, an all-hazards mitigation plan can provide recommendations to help prevent and minimize the damages resulting from such events, and

WHEREAS, the adoption of an all-hazards mitigation plan is required to be eligible to receive State and Federal funding for hazard mitigation initiatives, and

WHEREAS, the Towns of Dryden and Newfield and the City of Ithaca are developing or have developed their respective hazard mitigation plans, and

WHEREAS, the County of Tompkins and the towns of Caroline, Danby, Enfield, Groton, Ithaca, Lansing, and Ulysses (Partners) executed a Memorandum of Understanding in 2003 to develop a Multi-Jurisdictional All-Hazards Mitigation Plan (Plan), and

WHEREAS, the Partners subsequently drafted the Plan in accordance with the requirements of the New York State Emergency Management Office (SEMO), Federal Emergency Management Agency (FEMA), and Disaster Mitigation Act of 2000, and

WHEREAS, the Plan includes jurisdiction-specific recommendations to minimize the damages associated with natural, human-caused, and technological disasters, and

WHEREAS, the Plan has been made available for public review online at the Tompkins County Planning Department Hazard Mitigation website (www.tompkins-co.org/planning/haz_mit.htm) and by placement in municipal offices, the Tompkins County Planning office, and the Tompkins County Public Library, with notices published in the *Ithaca Journal*, the local paper of record, inviting public comment, and

WHEREAS, public meetings were hosted by the Partners throughout the development of the Plan to discuss the contents of the Plan with members of the public, and

WHEREAS, comments from the public and Partners have been incorporated into the Plan, and

WHEREAS, the revised Plan is wholly supported by its reviewers, and

WHEREAS, once all the hazard mitigation plans for the respective jurisdictions in Tompkins County are complete, the County, Towns, and City of Ithaca will work to coordinate the implementation of the hazard mitigation plans, and

WHEREAS, the Caroline Town Board has reviewed the Plan and affirms that the Plan will be updated no less than every five years; now therefore be it

RESOLVED, by the Caroline Town Board, that the Town of Caroline adopts the Tompkins County Multi-Jurisdictional All-Hazards Mitigation Plan as its all-hazards mitigation plan, and resolves to execute the actions in the Plan.

Discussion: Beth Harrington gave favorable comments on the plan. Urges our Planning board to look at the plan in reference to their activities. Offered to spearhead public awareness efforts for parts of the plan. Also offered services for NIMS compliance for federal disaster money. Noted that all fire departments and the town itself get their fuel from the town fuel depot and that they have a generator for possibly three days. Don suggested that we look into getting generators for other town organizations, like the school. Grants: fire companies can apply for grants from private industry, not much federal funding.

Resolution 4-6 of 2006 Appoint Building Code Officer

This position is a part-time position (less than 40 hours per week) and is paid a weekly salary of \$675.96. The responsibilities are described in the Civil Service Position Description by this title. The appointee is responsible for the towns of Caroline, Harford, and Richford. The position is provisional pending passing the civil service exam for this position being offered on June 3, 2006. The appointee must have filed an application with the County Personnel no later than April 24, 2006, and it is further

RESOLVED, that pursuant to Title B of Article 4 of the New York Civil Service Law (and Sections 63, 64, and 65 therein, all as now exist or as hereafter amended), the Town of Caroline reserves all rights of termination of this temporary and/or provisional hiring and appointment, including, but not limited to, rights of termination relating to the person or the position based upon the temporary nature of this appointment, the probationary nature of the initial hiring, the legality of any hiring or appointment, and the provisional nature of the appointment made to fill the position in question, and the civil Service classification(s) thereof.
