- Have an invoice from PERB for putting the dropped grievance on their agenda. Union has paid their fee, I asked them to pay ours, they refused to pay the \$50; is much less than the cost to fight. Will put in next month's abstract unless TB advises differently

- Board of Health: possible creation of tobacco free zones (voluntarily) in buildings the county owns or does business in. Looking at inst. draft water well permitting program.
- Planning committee: affordable housing strategy (very preliminary)

- TCAT: applied for and received JARC funding, 1st round was to help individuals of certain income get to work, this round will help develop new routes and buy some hybrid buses

- Flashing lights at Caroline school: DOT says change in vehicle traffic law has changed the application process. New law states the DOT owns, installs light and school district pays yearly fee. Will need to start the process all over again once we receive letter from DOT.
- Building code officer needs new computer; current machine will not run Windows XP, which is needed in order to run new code software.

### **Planning Board Applications**

Chris Fillinger: would like chance to have impact on the town's environs. Has lived on both shores and in middle of the country. Experience: noise committee; district commissioner for fire dept. TB: what is your

vision of Caroline in the next 20 years? Chris: Regional compromises for development. TB: gathering public input is job of PB. Chris: would be a good learning experience. PB: your thoughts on the comp plan? Chris: all admirable goals, and a lot more work than even a pessimist might realize. TB: views on noise committee process? Chris: very valuable, and more work than we thought, but we gathered a lot of opposing views to put together a basic recommentation. Important to find a compromise that will work for most people.

Bev Liddington: Important to give back to your community; easy to complain, but harder to take part and shape the change that will happen down the road. Experience: subdivision committee; youth board; after school program; aux to fire company. TB: subdivision review board; how did you find the experience? Bev: tough, must take lots of complaints, but we worked out a good and fair plan. Also being a mother and wife is experience. Lived in town for 47 years. TB: your vision in 20 years? Bev: a lot like it is now; not a lot of big business, but allow people freedom on their land. Like to think that younger kids coming in will have what we've had here. TB: getting people involved? Bev: I think I could be effective; important for people to know what planning board is all about; too many rumors, people don't try to get real answers. Having lived in the community for a long time, I can reach out to other people who have been here a long time. TB: next step for PB is development guidance system. Bev: If on the committee, I would give it a lot of thought.

Board members felt both candidates very capable of serving on the Planning Board. Vote: Bev Liddington

### Annex engineering proposals

Tim summarized proposals. Think of them as all-inclusive with the exception of septic system, alternative energy or alternative heating systems, topographical survey.

All in line with each other. David Klein (DLK) has lots of municipal and historical experience. Both David and Schickel have dealt with public bidding process. Hunt doesn't have to pay a subcontractor for engineering as the other two would. All proposals can probably be negotiated. All bidders offer pre-referendum and post-referendum breakdown.

Tim will get clarification from DLK on pre-referendum numbers before next month's meeting.

Board will seek residents to form committee on the design of the building.

#### Noise Law development process

Tim handed out a template of noise law recommendation from committee. Board will formulate a list of questions for the noise committee; e.g., target shooting, gas drilling, generators. Should complaints to be resident-driven? Dogs. Don is working with the SPCA & Guy Krogh on enforcing the existing dog ordinance.

Board will have a working session or two and invite the public for comment before forming the law.

Committee felt strongly that permitting be involved. Granting variances is not restrictive, but is an avenue for residents to pursue exceptions to the regulation for certain occassions (such as an outdoor rock concert). Ed will request that the PB look into the variance process so they can provide a recommendation for blanket variance to apply to any future laws, not just noise.

### Memorandum of Understanding between Highway Superintendent and Emergency Personnel

WHEREAS, the Town of Caroline and its highway superintendent have resources at their discretion that may prove useful in serving the public outside the strict applications of the NY State Town Law; therefore be it

RESOLVED, that the Town Board of the Town of Caroline, by request of the town highway superintendent and by such authority as extended by applicable sections of the town law of the State of New York, do hereby permit, authorize, and direct the town highway superintendent to fulfill such additional responsibilities from time to time as circumstance necessitate, although such activities may not relate directly to the specific responsibilities of the highway department of the Town of Caroline as specified by the highway law. This includes:

1. The removal of snow, as required, from all municipal properties and the maintenance of outdoors safety conditions thereon;

- 2. Emergency assistance as may be requested by the chief or other responsible officer of a local fire company, in support of fire and EMS-related emergencies;
- 3. The rendering of such assistance as may be requested from time to time to cope with related emergency situations of any special district within the Town of Caroline, including school districts;
- 4. The use of town highway department resources as may be determined by the highway superintendent to be necessary and in the best interests of the general populace of the Town of Caroline

It is understood that there are reciprocal activities provided to the highway department by the fire and EMS agencies in certain emergencies.

This resolution is hereby submitted in the interest of and for the protection of the Town of Caroline, its highway department, and its full complement of personnel.
