Resolution 10-1 Lighting Extension

By Supervisor Barber; Seconded by Councilman Frongillo

RESOLUTION APPROVING ORDER AND

ESTABLISHING LIGHTING DISTRICT EXTENSION

WHEREAS, the Caroline Town Board previously established a town-wide lighting district, and had previously authorized the preparation of a map, plan and report ("MPR") by Resolution 8-5 (August 14, 2007), and the Town Board having reviewed and accepted the MPR as final; and

WHEREAS, the extension of the Town-wide Lighting District was (and is here again) deemed to be in the public interest, and the Town Board had (i) previously declared and described the boundaries of the district as including all properties defined, drawn and described in the MPR, (ii) determined that the extension includes no construction or financing costs, and only includes operation and maintenance costs for the maintenance of the extension, with such first year annual costs to be \$93.10, (iii) ordered a copy of the MPR to be filed at the

Town Clerk's Office in accordance with law, and (iv) determined that all properties included were benefited and that the district extension was in the public interest; and

WHEREAS, the Town desires to proceed towards extension of Town-wide Lighting District pursuant to the provisions of Town Law Article 12-A; and finds that all proceedings to date have been in compliance therewith; and

WHEREAS, the Town Board of the Town of Caroline duly adopted a Resolution and Order upon September 11, 2007 that resolved, directed, determined, and/or declared (i) that the final MPR complied with the requirements of Town Law; (ii) that the MPR was approved and adopted; (iii) that it was in the public interest and a benefit to all parcels in the Town-wide Lighting District to proceed with the proposed district extension; (iv) that the extension consisted of the installation of one street light at the Speedsville Store electric pole; (v) that the capital and construction costs of the proposed improvements for the extension were \$0.00, which was the maximum amount proposed to be expended; (vi) that there was no financing needed for the project; (vii) that the MPR was on file for public review and inspection at the Office of the Town Clerk; (viii) that the MPR described in detail the costs and expenses, including the first year's estimated average maintenance cost of \$93.10; (ix) that such costs were proposed to be paid through property tax assessments to be collected with the annual Town and County tax bill in the district; and (x) that a Public Hearing be set and held at 7:00 p.m. upon October 2, 2007 at the Caroline Town Hall, 2670 Slaterville Road, Slaterville Springs, New York upon the Town Resolution and Order to extend the Lighting District; (xi) that the Town Clerk publish and post notice of such public hearing in accordance with law; and (xii) that the Town Clerk file a certified copy of the Resolution and Order with the NYS Comptroller at or about the time of the publication thereof; and

WHEREAS, a Public Hearing was duly held at 7:00 p.m. on October 2, 2007 at the Caroline Town Hall, and all persons interested in the subject hereof were duly heard, and all relevant evidence was taken and recorded; and

WHEREAS, the Town Board has determined that the matter was not subject to SEQRA review pursuant to 6 NYCRR §§ 617.5(11), 617.5(16), 617.5(20) in that the project will have no environmental impacts and falls within exempted classifications as a minimal extension of utilities within an existing and approved district, and/or as it constitutes the installation of a traffic and safety control device, and/or as such action constitutes a routine agency maintenance and management issue per Town Law §64; and

WHEREAS, neither the costs per EDU nor this extension, as an extension of a Lighting district, are subject to NYS Comptroller review such that an application to, and permission from, the NYS Comptroller is required; and

WHEREAS, upon due deliberation upon the foregoing and the public interests to be served and the properties to be benefited thereby, the Town Board of the Town of Caroline has hereby

RESOLVED AND DETERMINED, that: (i) the Notice of Hearing was published and posted as required by law and was otherwise sufficient; (ii) all property and property owners within the District Extension are benefited thereby; (iii) all benefited properties and property owners are included within the District Extension; and (iv) that the establishment of the District Extension is in the public interest; and it is further

RESOLVED AND DETERMINED, that the boundaries of said District Extension are (i) wholly outside the boundaries of any incorporated city or village, and (ii) are defined as inclusive of the whole of the Town of Caroline; and it is further

RESOLVED AND SO ORDERED, that the establishment of the Town of Caroline Lighting District Extension be and hereby is approved; and it is further

RESOLVED AND SO ORDERED, that the said District Extension hereinabove referred to shall be constructed as set forth in the Order calling a public hearing, with annual operating costs as set forth in the Order, which costs shall be paid by the district through the assessment, levy and collection of special assessments upon the several lots and parcels of land within the said District Extension, which the Town Board has determined, and hereby again determines, are especially benefited thereby; so much and from each as shall be in just proportion to the benefit thereof; and it is further

RESOLVED AND ORDERED, that the Town Clerk shall file two certified copies of this Resolution with the New York State Department of Audit and Control (at the NYS Comptroller's Office) within 10 days hereof; and it is further

RESOLVED, that this Resolution is subject permissive referendum pursuant to Town Law §209-e and Town Law Article 7.

Resolution 10-3

Establish Public Information Advisory Committee

WHEREAS, during the recent debate about noise, many residents expressed to the Town Board that Town informational postings through the Ithaca Journal, Brooktondale community newsletter, fliers, Town website, and Town email listserv were insufficient and unreliable as methods of communication with a large number of citizens, and

WHEREAS, democracy is strengthened when citizens are informed about and engaged in local government, and

WHEREAS, the Caroline Town Board desires to encourage participation of citizens and recognizes the importance of making available accurate, timely, and widely-accessible information on the activities of local government to all citizens, now therefore be it

RESOLVED, the Town Board seeks to establish a citizen advisory committee to recommend and help manage an expanded system for distribution of local government minutes and announcements; and also be it RESOLVED, that this advisory committee will:

- 1. Research methods of information distribution to citizens, and the extent to which those methods are currently used in the Town. These methods may include (but are not limited to) local newspapers, Brooktondale community newsletter, local radio stations, bulletin boards, posted fliers, e-mail listservs, billboards or signs, and so on.
- 2. Consider if it is town government's responsibility to ensure everyone receives information or everyone has access to information.
- 3. Based on the answers to the questions above, explore strategies employed by other municipalities, identify key gaps in distribution of information on local government in Caroline, and recommend specific options to fill those gasps. Recommended options should meet the following criteria:
 - a. Accurate, timely, and widely-accessible
 - b. Low cost to taxpayers
 - c. Reliability over time
- 4. With consent of the Town Board, implement and volunteer help needed to maintain these methods...

RESOLVED that the Caroline Town Board hereby authorizes up to \$27,000 from fund CD201 to be used to extend the current Housing Rehabilitation program, and be it further

RESOLVED that the Caroline Town Board desires to extend the contract with Better Housing for Tompkins County for the administration of this program.
