## A Local Law of the Town of Caroline, State of New York, Providing for a Partial Tax Exemption for Real Property Owned by Persons with Disabilities Whose Incomes Are Limited by Reason of Such Disability

Section 2 of Local Law No. 5 of the year 2000 of the Town of Caroline entitled "A Local Law of the Town of Caroline, State of New York, Providing for a Partial Tax Exemption for Real Property Owned by Persons with Disabilities Whose Incomes Are Limited by Reason of Such Disability," as amended by Local Law No. 3 of the year 2002, and further amended by Local Law No. 1 of 2004.

Real property located in the Town of Caroline owned by one or more persons, each of whom is disabled, or real property owned by husband and wife or siblings, one of whom is disabled and *who shall meet the conditions, qualifications, exclusions, and limitations set forth in Section 459-c of Real Property Tax Law, shall be partially exempt from taxation by said Town for the applicable taxes specified in Section 459-c based upon the income of the owner or combined income of the owners. Such partial exemption shall be to the extent set forth in the schedule following.*

Less than or equal to \$28,000	50%
Equal to or more than 28,001 but less than 29,000	45%
Equal to or more than \$29,000 but less than \$30,000	40%
Equal to or more than \$30,000 but less than \$31,000	35%
Equal to or more than \$31,000 but less than \$31,900	30%
Equal to or more than \$31,900 but less than \$32,800	25%
Equal to or more than \$32,800 but less than \$33,700	20%
Equal to or more than \$33,700 but less than \$34,600	15%

Equal to or more than \$35,500 but less than \$36,400	5%
Equal to or more than \$36,400	0%
