#### **Town Business**

The Highway Superintendent, Cindy Whitaker talked about this past winter season and the salt usage on the road. The cost of salt is high, and they purchase salt based on the previous season; sometimes they run out depending on the demand to maintain the roads. Also if they are put on notice by the police department about icy conditions they are required to respond, this requires more man power and salt usage. Councilmember Witmer talked about hardpacked snow and being able to try on that which many people prefer. Cindy responded that it is actually more labor intensive because when it snows the sand goes down and it gets packed but when the snow starts to melt you need to put chains on to plow and you wind up plowing up black top. It creates much more work, then trying to keep the roads clear using salt and plowing.
