Caroline Town Board Meeting Minutes of June 6, 2017

The Town Board Agenda meeting held on June 6, 2017 at the Caroline Town Hall was called to order at 7:02 p.m. by Supervisor Mark Witmer.

Mr. Witmer started the meeting with the Pledge of Allegiance to the Flag.

Privilege of the Floor

Bob Spaulding – After listening last month to comments concerning the proposed rail bed trail and in particular the expressed wish of individuals in favor of the proposal to find a compromise. I came away wondering what that compromise might look like. At this juncture I am still unable to imagine any compromise that would be acceptable to affected landowners. Instead I see the outcome as a dichotomy; very much a win or lose situation. If the proposal goes forward, the only thing compromised in the end would be the rights of property owners to fully enjoy the fruits of their labor and investment. While a number of the people who favor the trail have pointed out their desire to use same for safer bicycle riding, we should remain focused on the reality that such a trail could never be justified as a transportation corridor. At best the trail would be a seasonal source of recreation. We are blessed both here in Caroline and the county, as a whole, to have a myriad of available and accessible recreational opportunities.

So, once again, this brings me back to a question of whether the basic rights of property owners should be compromised to provide privileges for others who have neither investment nor tangible need. I see no legitimate need for the trail to be extended as proposed. We have other real infrastructure needs that should have priority. Let's begin to think about getting a dollar's worth for every dollar we spend rather than wasting time and money on things we don't really need.

Sam Trechter – advocate for extension of South Hill Recreation Way. If there's an easement issue, whose property is it? Question how much claim adjacent landowners have in adopting the rail land. Roads such as White Church and Coddington are not safe.

Marty Hatch - Interested in Chrys Gardner's presentation. Caroline is an adoptive town.

Connie O'Brien – Appreciative of the Town's improvement efforts. In support of the Trail. Brought petitions in support of trail extension containing approximately 50 signature, about half of which are Caroline residents.

Betty Dean – A trail in Caroline leading to Ithaca is a good idea however, does not agree with the path of the trail cutting too close to homeowner's property invading privacy & way of life. The old railway is a utility easement, not a public right of way.

Scott Dean – hunting sport cameras on posted property (Beaver Creek Rd) picked up walkers with dogs trespassing on posted land. Private property luxury is being threatened.

Building and Grounds

 \cdot Have read Historic Structure Report by Sam Coon (Cornell University) and am in the process of incorporating its recommendations into an RFP to have the Historic Town Hall painted.

Emergency Services

 \cdot Have reviewed attorney's feedback regarding question of creating a "First Response" district as opposed to an ambulance district. While the town could create a district, it would still need to either a) create a service provider or b) contract with a current service provider. Both of these options have been previously explored and found to be unfeasible due to economic and staffing constraints.

• I have concluded that the only viable path forward for Caroline is to try to create a first responder network, which will require cooperation between the Fire District Commissioners and the Fire Chiefs of the three town squads. Core issues include: permission for a fire department to conduct first response activities in another district; allowing personnel from other fire departments to attach as first responders with Brooktondale Fire Department, the only squad that currently has recognized first response service. An appropriate next step would be for the town to request a meeting with the Fire Commissioners and Chiefs to discuss this possibility.

Greater Tompkins County Municipal Health Insurance Consortium

· Attended the May 25th meeting of the consortium.

 \cdot The Board received the Audit Report from Insero & Company, which revealed no material weaknesses on the part of the consortium.

• The consortium is currently evaluating its governance structure due to significant growth in participating municipalities. Currently, each municipality has a representative on the board and, as a result, the board size has grown to over 30 members. A sub-committee has been created to consider alternative structures. I have joined that sub-committee.

 \cdot If the Town of Caroline is going to make any changes to its current health benefits plan, the consortium must be notified of the changes by October 1, 2017.
