Whereas, the Town of Caroline was awarded a BridgeNY grant from NYSDOT for culvert replacement on Boyer Creek at Ekroos Road in 2018; and

Whereas, the Town of Caroline was also awarded a WQIP grant from NYSDEC for culvert replacement and stream stabilization on Boyer Creek at Ekroos Road in 2018; and

**Whereas**, the Town performed emergency culvert replacement at Ekroos Road in 2018 that can be applied to the 25% town share for the WQIP grant; and

Whereas, the NYSDEC is working with the Town on a modified plan that will build upon the emergency culvert replacement, enhance aquatic passage, and stabilize stream bed and bank; and

Whereas, the BridgeNY grant would require replacement of the new culvert; and

Whereas, the awarded BridgeNY funds cannot be applied to other projects in Caroline; therefore be it

**Resolved**, the Town of Caroline relinquishes the 2018 BridgeNY Award from NYSDOT so that the funds can be directed where needed.
