Privilege of the Floor Policy at Caroline Town Board Meetings

Presentation from the Local chapter of Cycle-CNY

Cycle -Trail riding. Local chapter of the international biking Represent southern tiers. There are 100 or more paid members in the Southern Tier Chapter Trail maintenance. They have group mountain bike rides. At times, upwards of 40 or so bikers join together for a ride. Not for profit. A natural resource with the DEC since 2004. The chapter has done about 4000 hours trail maintenance. All approvals come from the DEC. Yearly planning of what plans are volunteer State forest 20 miles of marked skiing. Shindagin is not open to horses.

2004 DEC, Caroline highway assists the Cycle-CNY by keeping the access roads open. Shindagin Hollow trail is catered to mountain bikers. Very unique forest. The Dec gives permission but the Chapter pays for improvements with donations, and membership dues, etc. Led some courses Cindy Whittaker, Highway Superintendent has helped when piles of unwanted trash. The bike chapter picks it up, puts it a pile and the Highway crew will pick it up upon request.

Parking is an issue. DEC put in a 6-car parking spaces and then a new 15 space parking lot is on the agenda for the DEC to put in this spring. With increased traffic on Central Chapel Road, they are requesting a speed limit change - lowering it from 55mph to 40mph or 45mph. Mark Witmer explained the process in requesting the change. The process includes the Town Highway Superintendent putting in a request to Department of Transportation, along with letters and/or petition from residents who live on the road who are in favor of

lowering the speed limit.

Gave thanks to the Brooktondale and Slaterville Fire District for their support. They often stay connected by supplying the districts with up-to-date maps of the trails in case of medical assistance/support needs.

Reports

Cindy Whittaker, Highway Superintendent - Grove School Road closed due to culvert collapsed. Crews are busy with snow and ice removal.

• Len Pogorzala and Alan Karasin have again volunteered to serve on our local Board of Assessment Review (BAR). Dan Klein will also attend, along with Tompkins County Assessment personnel. Caroline's BAR date is Monday, May 7th, 3-6 pm at the Town Hall.

• Attended Association of Towns meeting in New York City from February 19-21. Notes:

• Senator Schumer mentioned that there are a lot of federal funds for broadband and urged people to let him know if they had needs.

- The Real Cost of Roads by David Orr of Cornell Local Roads.
- Capital planning for water in Plattsburgh. Performance Systems Contracting for building remodels.
- Greene County has emergency services funded by county sales tax.

• New York Energy Code for Municipal Officials. Discussed with Kevin hosting an Energy Code Training locally for builders and code officials and will be moving forward with that. Will promote through TCCOG.

• Times Square is surreal.

• Energy Independent Caroline met with students in Cornell Environmental Psychology class beginning their pilot work on resident energy issues in Caroline for this spring term.

- J.B.'s Excavation was awarded the contract for Buffalo Road Creek Streambed Stabilization II.
- Subdivision and Site Plan Review Laws are near completion. Expect to introduce them to the board within the next week.

• Electric-vehicle charging station at the town hall is now operational. A needed cell-signal extender installed in the town library is providing improved cell signals at the town hall. (I can see the icon on my phone). The \$17,000 charging station was primarily funded by NYSERDA (New York State); the town out-of-pocket investment was \$519 plus donated bollards and excavation work by the Caroline Highway Department.

• Attended LED Streetlight meeting organized by TCCOG at Borg-Warner Room on March 12. George Woodbury, a recognized expert on streetlight conversion whose firm LightSmart is converting Rhode Island streetlights to LEDs, spoke to us about the mechanics, technology, and economics. Mr. Woodbury is evaluating Caroline's streetlight infrastructure purchase offer from NYSEG.

• Terry Carroll and Lee Yoke of Cornell Cooperative Extension have let me know that they would like to begin "truthing" Caroline streetlights with a GIS inventory. This is an important aspect of evaluating NYSEG's purchase proposal and developing the streetlight design plan.

- Alanna Congdon from Tompkins County gave the clerks and myself a brief tutorial on laserfiche. It is amazing. Propose for Court and History Room.
- Worked with Marilou to comply with NYSLRS Standard Workday Resolution reporting.
- Spoke with Susan O'Rourke, V.P. of NYMIR to clarify insurance coverage for Caroline Sports Association.

Resolution Authorizing the Town Highway Superintendent to Aid Fire Companies and Other Emergency Personnel, as Circumstances Necessitate

A motion was made by Mark Witmer and seconded Cal Snow

Whereas, the Town of Caroline and its Highway Superintendent have resources at their discretion that may prove useful in service the public outside the strict application of the New York State Town Law; therefore be it

Resolved, the Town Board of the Town of Caroline, by request of the Town Highway Superintendent and by such authority as extended by applicable sections of the Town Law of the State of New York, do hereby permit, authorize, and direct the Town Highway Superintendent to fulfill such additional responsibilities from time to time as circumstances necessitate, although such activities may not relate directly to the specific responsibilities of the Highway Department of the Town of Caroline as specified by Highway Law, including:

1. The removal of snow as required from all municipal properties and the maintenance of outdoor safety conditions thereon;

2. Emergency assistance as may be requested by the Chief or other responsible officer of a local Fire Company in support of FIRE AND EMS-RELATED EMERGENCIES;

3. The rendering of such assistance as may be requested from time to time to cope with related emergency situations of any Special District within the Town of Caroline, including school districts;

4. The use of Town Highway Department resources as may be determined by the Highway Superintendent to be necessary and in the best interests of the general populace of the Town of Caroline.

It is understood that there are reciprocal activities provided to the Highway Department by the Fire and EMS Agencies in certain emergencies.

This resolution is hereby submitted in the interest of, and for the protection of, the Town of Caroline, its Highway Department, and its full complement of personnel.

Urging that Charter Communications Maintain WSKG Public TV Service in Tompkins County.

Whereas, we have been notified by Charter Communications (parent company of Spectrum Communications) that on or after March 15, 2017, WSKG Public TV service in Tompkins and Cortland Counties will be dropped from their offerings; and

Whereas, WSKG is one of only two PBS TV stations in our area, providing informative news and local programming not influenced by corporate sponsors; and

Whereas, WSKG Public Broadcasting covers 21 counties across New York State supported by 10,000 contributors, with about 1/4 (2,500) of those residing in Tompkins and Cortland Counties, showing that WSKG Public Radio and TV is strongly supported in our region; and

Whereas, the decision to drop WSKG TV from our region was justified as a business decision, but unlike forprofit stations, PBS stations are offered free-of-charge to carriers; and **Whereas,** dropping WSKG TV from Tompkins and Cortland Counties would undermine the financial security of WSKG and remove WSKG TV programming from a region where it is strongly valued by the public; therefore be it

Resolved, the Caroline Town Board urges Charter Communications to maintain WSKG Public Television service in our region; and further be it

Resolved, that any future consideration of changes to carrying PBS stations by Charter Communications be informed by public input that is well advertised; and further be it
