Broad Band- Although the concept behind public financing of last mile for high speed internet was to provide service for those areas that would not likely see private sector build-out, actions be the NYS Consolidated Funding Application Committee proved differently. NYS did not fully fund the Clarity Connect proposal the Caroline TB endorsed. Instead it told Clarity Connect to not build-out in Caroline and Enfield and 2-3 towns in Cayuga County. Because Clarity Connect

kept the County Emergency Communication tower at Taft Road in his revamped proposal, greater than 50% of Caroline will be served by the original grant. In addition 2 Danby towers will help sections of Brooktondale and White Church.

Caroline has several things working against us. From NYS and CC point of view

- 1. Caroline build-out had 1/6 of the cost for 1/14 of the population
- 2. Caroline enthusiasm with a 3-2 decision was considered low for enthusiasm
- 3. Required franchise agreement was only one. CC has some misinformation about the purpose and structure of such an agreement.

Because NYS wants money spent asap, Clarity Connect will start as soon as Friday (but not in Caroline). To get action in Caroline, we need to alert prospective customers of HIS to contact Clarity Connect NOW!!!

The remaining build out will cost ~\$500K. There is another grant for July 2013 with funding in fall. Cayuga County where the completed build-out costs less than Caroline has all of the Towns pitching in. No illusion that will happen here.

If completing the build-out is a priority, we need to determine such by door to door survey of unserved households and work on funding from other sources like County, other muni's, Town of Caroline, and private sector.

State grant will chose lowest cost/subscriber build-out. Since we are starting high, the only way to be successful with the grant is to have significant local funding. Suggest we form a citizen action committee and determine how much energy and importance to completing the HIS Build-out.

Discussion: The board discussed how the process would go to oversee the funds for the Solarize Tompkins SE project. Councilmember Linda Adams had concerns about the legality of funds coming to the Town of Caroline (in the form of a grant from the Park Foundation) and if the Town would face any issues by dispersing the funds to Solarize Tompkins SE. She also wondered about the "quickness" of putting a resolution through, making the Town liable for handling the funds. There was also discussion about how the processing of the funds would be handled when reimbursing for purchases; paying funds out for an itemized list of items not yet purchased. Also there was a question in regards to the hiring of Mark Witmer as the manager/organizer of Solarize Tompkins SE.

Councilmember Adams asked why a volunteer group such as Solarize Tompkins SE didn't use the full grant for the solar project to help the community and have a volunteer chairperson (like other Town committees). Supervisor Barber responded that the grant monies were dispersed to Solarize Tompkins SE and were only being overseen by the Town. The committee requested from the Park Foundation, as part of the grant, to have a portion of the funds available to pay for a manager/organizer.
