Caroline Town Board Meeting Minutes of September 10, 2013

The Town Board Business meeting held on September 10, 2013 at the Caroline Town Hall was called to order at 7:00 p.m. by Supervisor Don Barber.

Privilege of the Floor

Peter Hoyt wanted to reiterate his opinion about recommending Bob Anderson to fill the remainder of the open term (until 12/31/2013) on the Town Board. Pete said "Bob would bring in an interesting perspective which might be an 'eye opener' to the board". He said the Town Board should not be made of up ideological members but offer diversity. He said that this a "low risk opportunity" that wouldn't change "the set" make up of the board but would be good to have a different point of view.

Don Dingler a long time resident of the Town of Caroline spoke to the board about lowering the speed limit on the 76 road in Brooktondale. There is problem with motor vehicles speeding in residential areas. In one area there is a children's daycare in operation. Don Dingler had presented a petition to the board asking for their support in lowering the speed limit. The signatures came from residents living on 76 Rd. There is 34 individuals that signed the petition plus it contained statements of individuals who had been a witness to the excess speed used by motor vehicle drivers. The petition asked the Town Board to request the NYS DOT to lower the speed limit from 55 mph to 45mph. Supervisor Barber asked which areas of 76 Rd was of the most concern of the speeding. Don Dingler spoke about Caroline Center which is marked at 30 mph but drivers go over 55 mph through that area and then lower to 45mph an area of the 76 road to the West Fall Corners that is most populated. Supervisor talked about asking law enforcement to set up speed enforcement in those area, and working with enforcement about sections of road that the residents were suggesting the lower the speed limit from 55 mph to 45 mph. The board will discuss the proposal and petition and then bring forward a resolution, which if passed, will make a recommendation to the DOT for lowering the speed limit on 76 rd from 55 mph to 45 mph.

Report:

- 1. The National Resource Conservation Services (NRCS) funded project for 600 Road stream bed and bank stabilization is not happening this year. Barry and I are meeting with NRCS staff tomorrow to speak about process for extension.
- 2. Contacted by Office of State Controller (OSC) to perform an audit. Triggered by DA fund which has been spending more that revenue. I told them we knew and when FEMA reimbursed us, this would no longer be a problem. After several meetings with me, the clerk, bookkeeper, and Highway Supt, they ended their audit with one recommendation: Board needs a better audit of Supervisor books. They gathered info about Solar panels to determine the savings for possible info source for other municipalities.
- 3. Met with Dog Control Consortium the group is looking to develop an RFP for an enumerator that handle roughly one third of our group's homes per year, but we would all pay our portion on a 1/3 per year basis
- 4. Broadband: Recent email from Chuck Bartosch saying that the state granting agency apparently put out an alert that had the wrong date for the grant applications to be submitted for this fall. Bartosch discovered with too little time to develop an application. He claims there will another opportunity in 2014. 31 minutes

Speedsville Fire Department- Rick Morgan will be attending an EMS refresher course. Discussion of the budget at Speedsville; they will be asking for a budget increase. They need pump heaters to keep the pumps from freezing while fighting fires in the winter months. The cost is \$2500 for each pump heater. They are also requesting 6 new turn-out suits (gear) @ \$2000 a suit.

They want to be kept apprised of public building inspections, problems found and the follow up. They want to also be kept updated on all the unsafe buildings, what the reports say and the follow up. When discussed what the protocol would be to follow, Supervisor Barber suggested that a member of Speedsville Fire dept. should contact the code officer with their request (which Councilmember Weiser said that they already done through e-mail). Supervisor Barber also said that that council member Weiser should follow up with the other local fire departments about the additional requests (in addition to the permit status) and then follow up with Code Officer.

Councilmember Weiser visited other Towns board meetings and found that Danby has a monthly report from the Code Officer and Court Office. She was wondering if that might be a possibility to have a written report given to the Caroline Town Board from our Code Officer and Court Clerk.
