- Town's road miles (70 mi. in Caroline). Avg. expenditures in rural towns = 14K/mile/yr

NORA address-point mapping, cutoff < 25 mbps. Issued RFP. Fiber/wireless hybrid. "Reverse auction" through regional development. RFP will open on March 1. Vendor (Seneca Solutions) they chose serves

Native American communities. Engineered for ultimate buildout to all? Seneca Solutions potential vendor? REDC

- Whitespace in Thurman (pop. -1200). Evelyn Wood. Advantages: can supply cell services and signal is blind to vegetation. GIS. Worked with REDC. Residents supplied 50% of financing for their installs. 3 mb/s; \$50/mo. Shooting for 80 homes got 100. Very happy customers. Rainmaker Network Services. Town makes \$1,200 revenue. (Bill Goodman, Paulette Terwilliger, Holcomb, Jim, Karen Newfield). 2015 animal control summary submitted by Jim from SPCA (Correspondence File). Discussion of enforcement process and success. Requires follow-through from court. Service Animals - means physical assistance or medical (not emotional support, as previous). Can only ask a dog-owner what service the animal provides; apparently documentation or demonstration not required. Identified three avenues for promoting licensing:

Groton had success in licensing by sending out a letter of information to residents - netted 200 licenses. Letter will be shared with the group.

Promoting at public spay/neuter clinics and following up with recipients of this services. Pam will be sending out names and contact information to town clerks.

Promoting at Rabies Clinics. Similar follow-up??

We may want to educate about animal responsibilities in Old Mill.
