Caroline Town Board Business Meeting Minutes of November 12, 2020

The Town Board Business Meeting held electronically via Zoom teleconference on November 12, 2020 at 7:05 p.m. hosted by Supervisor Witmer

Public Hearing on 2021 Caroline Town Budget

Supervisor Witmer opened the Public Hearing at 7:06pm and gave a brief summary presentation outlining the General Fund, the Highway Fund, Caroline Fire Protection District and Caroline Lighting District. He made the following changes: A9060.8 from \$34,516 to \$34,090; A9060.802 from \$9,000 to \$12,339; DA9060.8 from \$223,753 to \$219,062. A Fund Balance to offset tax levy from \$194,000 to \$192,000.

Discussion regarding Town Reserve Funds. Councilmember Weiser shared concerns about the town fund balance being low. Supervisor Witmer states that because fund balance was used for the purchase of two new highway trucks that totaled over \$500,000.00, it lowered significantly and he too is concerned but he is committed to keeping costs down, and not have it impact the taxpayers. He recommended that they stay below the tax cap and keep the current budget where it stands this year and assess where things are at next year. Councilmember Snow agrees that this is a challenge and feels that they need the revenue to provide the services needed for the town. He would rather see small increases little by little than one large increase at one time. Further discussion regarding revenue lines and expenditures. It was agreed that the board will strategize on how to keep costs and taxes down and evaluate next year.

Supervisor Witmer closed the Public Hearing at 8:13 P.M.

Dan Klein, County Representative – County Budget Public Hearing was on Tuesday. The final vote is on Tuesday, Nov 17th. 2.2% tax levy increase, exceeding the tax cap. 6% reduction in workforce without any layoffs. Funded the broadband study. Various other towns, including Caroline pledged \$5,000 towards that effort. 0% salary increase for all County Legislatures. 30 new positive COVID cases in Tompkins County – 11 of those are Caroline residents.
