# **Library Discussion with Gale Moran**

Barbara Kone described the various guidelines that are in place at the Library. She noted that Caroline is the only library in Tompkins and other surrounding Counties that is still closed. Patrons are generally in the library for 10-15 minutes or less and most often, less than 3 people are in the library at one time. She asked that the Board consider reopening. Councilmember Murray clarified that the closure was because of the climbing number of positive COVID cases in the County in December and January months and felt it was necessary to keep residents and volunteers safe.

- Energy Independent Caroline is planning a final Brighten Up Caroline LED bulb distribution effort on <u>Saturday</u>, <u>April 24th</u>. - Tompkins County Council of Governments (TCCOG):
  - Broadband: TCCOG is forming an advisory committee to Tompkins County Planning and Sustainability on the Southern Tier Network/Fujitsu study for a countywide municipally-owned "middle-mile" fiber network to be conducted and completed this year. Nick Helmholdt is the county lead.
  - Community Choice Aggregation (CCA): This subcommittee chaired by T. Ithaca Supervisor Rod Howe, working with Terry Carroll at CCE, is forming a working group of municipal officials to draft a basic CCA agreement that would allow modifications going forward to facilitate additional community goals.

**Jessie Townsend, Town Clerk** – The Clerk's Office has collected 83% the total tax warrant. Has submitted the final tax payment to the Town Supervisor this week.

**Bob Spencer, Highway Superintendent** – Equipment - Has supplied the Board with an installment plan option for the purchase of new trucks. Further discussion regarding new equipment purchasing needs. He asked the Board to commit to the purchase of a new truck in 2022. Councilmember Murray asked that he put together a rotation schedule to better understand the capital planning for the future. Board members also asked for repair tracking as Bob noted that the repair cost on these older trucks are increasing every year. Building and Grounds - Repairs made to the newer building have been completed. Bob and crew are happy with the improvements. Bald Hill Cell Tower – After many delays and re-routing, Spectrum is working to complete the project soon. He will keep the Board updated when he has an official date as to when the tower will be operational.

**Tim Murray, Councilmember** – Planning Board Meeting is tomorrow night (February 11, 2021) at 5:30 p.m. to discuss the Proposed Law for the Siting of Solar Electricity and Battery Energy Storage Facilities.

**Dan Klein, Tompkins County Legislature Representative** – Dan was not present for the meeting, but offered the following information: The appropriation of \$15,000 from the County to the Town of Caroline passed committee last week, and will be passed by the full legislature Tuesday night. This is money that was meant for broadband expansion in Caroline and was allocated by the County in 2013.

# TOWN OF CAROLINE LOCAL LAW NUMBER 2 of 2021

Amendment of Town of Caroline Local Law #1 of 2002 to Increase Membership on the Town's Planning Board to Seven Persons

The Town Board of The Town of Caroline, New York, pursuant to a Resolution dated February 10, 2021 does hereby pass a local law as follows, expressly superseding New York State Town Law, Section 271 (4) (5) (6) and Town of Caroline Local Law #1 of 2002 (To Establish a Town of Caroline Planning Board) to limit terms of appointment to no more than five years, rather than equal to the number of members on the Planning Board:

### **Section 1.** Authority

This Local Law is adopted pursuant to the authority granted in the New York State Town Law, Section 271 (Planning board, creation, appointment).

#### Section 2. Title

This Local Law shall be known as "Local Law Number 2 of 2021", titled "Amendment of Town of Caroline Local Law #1 of 2002 to Increase Membership on the Town of Caroline Planning Board to Seven Persons."

### Section 3. Purpose and Scope

The Town wishes to increase total membership on the Town's Planning Board from five to seven persons to enable additional participation by residents in Planning Board initiatives.

Members shall be appointed to terms no greater than five years.

Otherwise, all other provisions of Local Law #1 of 2002 shall remain in effect.

**Section 4.** This local law shall take effect following its adoption.

# Resolution 64 of 2021. Formation of a Town of Caroline Zoning Commission

A motion made by Supervisor Witmer and seconded by Councilmember Murray hereby agrees to the formation of a Zoning Commission as amended:

Whereas, from public input and the judgement of the Town's Planning Board based on increasing growth pressures and few development guidance tools to promote the goals of the Town, the Town's updated Comprehensive Plan recommends consideration of a zoning plan appropriate for Caroline; and

Whereas, for towns like Caroline Considering adopting zoning for the first time, a Zoning Commission must be established, which has the responsibility "to recommend the boundaries of the original zoning districts and appropriate regulations to be enforced therein, make a preliminary report, hold public hearings and submit a final report to the local governing board..."; therefore be it

Resolved, upon the recommendations of New York State and a professional planner, and after consultation with the Town's Planning Board, the Caroline Town Board hereby establishes a Zoning Commission of seven members, which shall include three members of the Town's Planning Board and additional Caroline residents appointed by the Town Board. A member of the Town Board shall serve as liaison to the Zoning Commission; and

Be it Further Resolved, the Town's Zoning Commission is a separate body with its specific charge to:

- a) examine existing conditions,
- b) through a process which encourages and accommodates public input recommend the boundaries of the zoning districts and appropriate regulations to be enforced therein,
- c) make a preliminary report of this information,

- d) hold public hearings on the preliminary report, and
- e) submit a final report to the Town Board"; and

Further Resolved, shall be disbanded upon submission of its final report to the Town Board.

It was noted that the Zoning Commission will be engaged in that process and report to the Town Board with the findings.

- 9. Provide Towns with More Options to Address Revenue Shortfalls and Cover Operating Expenses
- 10. Support Funding for Towns during COVID-19
- 11. Collaborate with Towns on Responses to COVID-19 and Vaccine Distribution
- 12. Create a Statewide Committee to Evaluate the Impacts of Recent Criminal Justice Reforms
- 13. Amend the Utility Moratorium on Termination of Services to Ameliorate the Financial Burden on Local Governments
- 14. Proactively Eliminate the "Dark Store Theory" as a Valuation Method to Reduce Real Property Tax Assessments

Resolved, the Caroline Town Board hereby authorizes the Supervisor to sign the 2021 agreements for collective purchasing of Workers' Compensation Insurance through the Comp Alliance with both the Slaterville Fire District and the Brooktondale Fire District.
