What's Happening in Caroline

Supervisor's Notes

Zoning Plan: At the April 5, 2023, Caroline Town Board meeting the Town's Zoning Commission presented their Final Report on Proposed Zoning Regulations for Caroline to the Town Board. The Town Board has now begun their own review before holding a Public Hearing and voting on adoption. I want to express my deepest gratitude to the members of our Zoning Commission, Chair Jean McPheeters, Ernie Bales, Michele Brown, Barb Knuth, Bruce Murray, and Bill Podulka.

Broadband: We are working with Hunt Engineering on a feasibility study for Caroline municipal broadband. Please return the enclosed broadband survey (or submit via the town website home page) to help us inform this study. We look forward to moving this initiative forward to enhance broadband access in Caroline.

Emergency Services Planning: As a result of discussions and planning over the past three years by a Tompkins County Council of Governments subcommittee, we are now honing a proposal for countywide support for emergency first response. Our goal is to improve emergency first response times and support our existing first-response agencies. The energy and expertise of the Tompkins County Department of Emergency Response has been invaluable. I will be updating the community on this initiative as it develops.

Sustainability: Brighten Up Caroline is now complete, having converted our streetlights and two fire halls to LED lighting and distributed LED bulbs to Caroline households. In addition to the energy and cost savings, the town now has much more control over operation and maintenance of its streetlights.

Capital Projects:

Highway Facilities. LaBella Engineering has been selected to design and administer construction of new highway facilities at the current site. We are just beginning that work and look forward to making this needed capital improvement a reality.

Historic Town Hall. We are working with Historic Ithaca on a Historic Renovation Grant for the Historic Town Hall. Susan Holland from Historic Ithaca and architect Steve Gibian are providing their expertise in developing the proposal. More soon!

Her willingness and ability to dissect and address matters head-on was invaluable to me as Supervisor and to our deliberations as a board. Thank you so much, Katherine.

The Town Board is now accepting applications from individuals wishing to fill Katherine's seat for the 2023 calendar year (this seat will be voted on in the fall 2023 general election for the remaining two years of the term, Jan 1, 2024, through Dec 31, 2025). The Town Board plans to interview applicants at the July 5th Agenda Meeting and make the appointment at the July 12th Business Meeting.

Assessments

On March 27, the Tompkins County Assessor and I met with a group of residents in Speedsville to talk about property assessment. Many people have seen their assessments go up sharply in the last 2 years. Assessments are an attempt to pinpoint the price your property would sell for, in as fair a way as possible.

Although no one likes their assessment to go up, it is obvious to most people that the housing market in Tompkins County is crazy. The median sales price for a 2-bedroom house in Tompkins County rose 37% in the last 12 months!

TC Legislature Report Cont.:

When you look at numbers like that, you see that for the most part, assessments do reflect reality.

If you think the County Assessment office got something wrong about your property, you should contact them to see what your options are.

Something I always tell people is that just because your assessment went up, it does not automatically mean that your taxes will go up. Two years ago, my tax bill went down by a few hundred dollars.

The thing local government can do to help is to try to keep the tax levy low. The levy is the total amount taken in by taxes. For the last 2 years, both Tompkins County and the Town of Caroline kept their tax levy change to zero. Unfortunately, the budget outlook for the County this year is not looking so good. I will report on that as it plays out over the year.
