Caroline Town Board Meeting Minutes of December 11, 2012

The Town Board Business meeting held on December 11, 2012 at the Historic Town Hall was called to order at 7:04 p.m. by Supervisor Donald Barber.

Interview for Planning Board member

Lois Lounsbery introduced herself and addressed the Town Board as an applicant for a position on the Planning Board member.

Councilmember Weiser asked Lois why she was interested in serving on the planning board? She said she was a farm land owner and had served from 2004-2005 on the Tompkins County Farm and Small Business Committee.

There is a Planning Board meeting this Thursday, December 13th at 6:30pm at the Historic Town Hall. Lois was asked if she was voted in by the board as a new member of the Planning Board could she attend the upcoming meeting and she answered in the affirmative.

Lois owns 125 acres and the land has been 50 years rented by the Snows so the land is used for crops. Lois spoke about industrial and/or commercial activity in the Town of Caroline and the environmental concerns involved.

Supervisor Barber explained that when the Planning Board does a Site Plan Review that the board does not say "yes or no" but moreover what you "can or can't" do.

Lois spoke about her vision for "nirvana",..... ...the goal to keep "farmland as farmland" in the Town. Supervisor Barber and Lois had a discussion about class 1 and 2 soils. Supervisor Barber explained that class 1 soils (land) has slight limitations that restrict their use where class 2 soils have moderate limitations that reduce the choice of plants or require moderate conservation practices.

Councilmember Weiser asked Lois if she knew the requirements for the Planning Board position; the board meets once a month, the 2nd Thurs at 6:30pm. She talked about the position requiring a monthly commitment. The term Lois would be filling is to serve for 5 years. The position also requires 4 hours training each year.

Councilmember Adams talked about the idea of balance in development. To learn from the past experiences, as an example to say "harvest timber in a responsible way". Lois talked about having land remaining for the future generations. She spoke with a developer (about her land) what is important-animals, trees, developing etc.

Supervisor Barber commented that the planning board had a process for looking at land development as opposed to a commitment to make judgments. He asked "Since you served on the Farmland Committee was there anything you would change. Lois responded that she had wished the process was more open instead of smaller groups getting together and making decisions.

Councilmember Adams asked her her goals for working on the committee? Lois answered that "Farmland, water use and the aquifer are key areas of concern and having land being used in a way that it can't be recovered".

Councilmember Snow asked, "Why did you apply?" Lois answered that she had thought about serving on a town committee for some time and Supervisor Barber had called and let her know there was an opening on the Planning Board. She said owning a large area of property in the Town of Caroline and knowing how important her property is to her and how important other people's property is to them that she cares about how the Town is developed.

Mark Witmer- Addressed the board about the resolution for gas rules extension. He said he thinks the SGEIS has stronger wording. DEC reading regulations were drafted for a 90 day extension. He said he thought that regulations should not be issued until the SGEIS is passed.

Resolution Requesting an Extension of Time for Review of the Revised Regulations for High Volume Hydraulic Fracturing

Whereas, the New York State Department of Environmental Conservation (NYSDEC) has established a 30-day public comment period from December 12, 2012 through January 11, 2013 on the revised draft regulations for high volume hydraulic fracturing; and

Whereas, the documents released for public review by NYSDEC number 338 pages including the revised regulations 6 NYCRR Parts 52, 190, 550 – 556, 560, 750.1, and 750.3; a summary and assessment of public comments; and additional analyses and impact statements; and

Whereas, the 30-day review period is completely inadequate for a thoughtful and thorough public review of the released documents and encompasses a period of time with major religious and national holidays; and

Whereas, due to Open Meetings Law requirements for advance public notice of agendas and supporting materials, the 30-day comment period essentially eliminates or severely hinders the ability for any municipal regulatory or advisory organizations, such as the Tompkins County Board of Health, **Tompkins County Water Resource Council** and the Tompkins County Environmental Management Council, to review the released documents and draft, approve, and issue comments; and

Whereas, these regulations are intended, in part, to mitigate impacts on local municipalities, and as described above, because of requirements of Open Meetings Law, and the monthly meeting schedule of local governments, a 30 day comment period virtually eliminates the ability of municipalities to draft, hear public comment, revise and vote on a response as to the adequacy of regulations designed to protect them, and

Whereas, the NYSDEC has not completed and made public its health impact assessment, and it is therefore impossible to comment on the adequacy of these regulations in mitigating these yet undescribed impacts, and

Whereas, the NYSDEC has not made public its revised economic impact assessment, and it is therefore impossible to comment on the adequacy of these regulations in mitigating these yet unseen impacts,

Now therefore be it Resolved, that the Caroline Town Board requests that at a minimum the NYSDEC extend the public comment period on the revised regulations to a minimum of 90 days so as to allow adequate public process at the local level and preferably that the NYSDEC not finalize the regulations on high volume hydraulic fracturing until after the SGEIS is finalized.

Be It Further Resolved that a copy of this resolution shall be sent to: Governor Andrew Cuomo; New York State Department of Environmental Conservation Commissioner Joe Martens, New York State Association of Towns, NYS Assemblywoman Barbara Lifton, and NYS Senator James Seward.

Town Roof Reserve Fund Resolution

RESOLVED, that pursuant to Section 6-c of the General Municipal Law, as amended, the Caroline Town Board hereby established a capital reserve fund to be known as the "Town Hall Roof Replacement Reserve Fund" (hereinafter "Reserve Fund"). The purpose of this Reserve Fund is to accumulate moneys to finance the cost of this capital improvement.

This resolution is subject to a permissive referendum as required by subdivision 4 of Section 6-c of GML. The Town Clerk is hereby requested to notify the public of this resolution.

When this resolution becomes official, the chief fiscal officer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The chief fiscal officer may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the investment policy of the Town of Caroline. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The chief fiscal officer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investments of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investments, and shall, at the end of each fiscal year, render to the Board a detailed report of the operation and condition of the Reserve Fund.

Except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of this governing board.
