Brief Description of Proposed Action (include purpose or need): The action is adoption of a zoning law for the Town of Caroline, designed to implement the previously adopted Town of Caroline Comprehensive Plan. To do so, the zoning establishes an Ag/Rural district encompassing the largest area of the Town, with specific districts for hamlets: Besemer, Brooktondale, Caroline, Caroline Center, Center Brooktondale, Slaterville Springs, Speedsville, and West Slaterville, and a focused commercial district. The overall purpose of the zoning law is to protect and promote public health, safety and welfare and to guide physical development of the Town in a manner which maintains and reflects the unique character of Caroline as a rural community, conserve the Town's natural resources and protect the environment, promote the Town as a vibrant and desirable community to live, including avoiding adverse impacts, support home occupations, encourage existing and new businesses, promote outdoor recreation, accessibility, and livability for people of all ages. As a first zoning law, the Town of Caroline had conducted its review and analysis and submitted its final report recommending zoning to the Town Board in March 2023. The zoning would be adopted as a local law, subject to all requirements as such.
