Refurbish a bottle for \$300-\$350 which would be dated for about 3 years. Which a new bottle is about \$500 a bottle will be good for 30 years.

They are looking for a used tankard as that is what is calling. The building is an on-going issue. They sealed the roof, put in 2 new furnaces, and worked on the floors, etc.

Insurance is a little less this year.
