Caroline Town Board Year End Business Minutes of December 28, 2020

The Town Board Year End Business Meeting held electronically via Zoom teleconference on December 28, 2020 at 9:11 a.m. hosted by Supervisor Witmer

Privilege-of-the-Floor

Bruce Murray made a statement asking the Town Board to not be in a hurry to adopt the Comprehensive Plan until the Town holds two in person public hearings so that the Town Residents can have a way to make their opinions known. He also made comments regarding the Task Force and specific building requirements and the Zoning Commission.

Supervisor Witmer stated that he feels that the community had many opportunities to make statements and comments by contacting the Supervisor or Town Clerk.

Councilmember Murray addressed Mr. Murray's concerns by clarifying that the focus of the Task Force was on commercial development not on non-commercial development such as home construction. Councilmember Fracchia noted Mr. Murray statement that the Zoom meetings at this time is appropriate due to the pandemic and he believes that the vote for Comprehensive Plan should be at the Agenda

Meeting or Business Meeting in January.

Councilmember Weiser indicated her agreement with Councilmember Fracchia, and she is also concerned about the impact on Solar Farms.

Additions and Deletions to Agenda

Councilmember Murray wished to add a comment about the Task Force recommendations and then withdrew his request in response to Councilmember Weiser's objection Councilmember Weiser, seconded by Councilmember Fracchia, called for deletions of the following discussions:

- 2. Negative declaration of environmental impact of the 2020 Comprehensive Plan
- 3. Resolution to adopt the 2020 Town of Caroline Comprehensive Plan
- 4. Approval of minutes of December 9
- 5. Motion for Executive Session to discuss legal matter re. town property at gravel pit

Supervisor Witmer rejects the deletions proposed since the items had been discussed at the December business meeting and the agenda was put forth in a timely manner; however, after further discussion can agree to delay to the Business Meeting.
